



USA Compression Partners, LP Announces Third Quarter 2018 Distribution; Third Quarter 2018 Earnings Release and Conference Call Scheduled for November 6

AUSTIN, Texas--(BUSINESS WIRE)--Oct. 18, 2018-- USA Compression Partners, LP (NYSE: USAC) (the "Partnership") today announced a cash distribution of \$0.525 per common unit for the third quarter of 2018, which corresponds to an annualized distribution rate of \$2.10 per unit, unchanged from the second quarter's distribution rate. The distribution will be paid on November 9, 2018, to unitholders of record as of the close of business on October 29, 2018.

In addition, the Partnership announced today it will release its third quarter 2018 results prior to the opening of U.S. financial markets on Tuesday, November 6.
